NHSE's management and leadership development programme

Leaders and managers in the NHS have been under considerable pressure and also considerable scrutiny of late. A number of recent reviews, primarily those undertaken by Tom Kark QC into the fit and proper persons test and Sir Gordon Messenger and Dame Linda Pollard into NHS leadership, have recommended improvements in the way those leading and managing NHS organisations are recruited, inducted, developed and supported.

In response to these recommendations, NHSE have worked with trust leaders and other stakeholders to plan an extensive programme of work to support management and leadership development at board level and across NHS organisations. The new fit and proper persons test framework and board leadership competency framework are the first publications as part of this programme.

In this session, two senior leaders from NHSE will talk about the context for this work, and discuss their future plans, including support for NED and chair recruitment and development.
